# Uzbekistan Airways and Air India Sign Interline Agreement During the 81st IATA General Assembly

On the sidelines of the 81st General Assembly of the International Air Transport Association (IATA), held in Delhi, a significant agreement was signed between the national carriers of Uzbekistan and India. Uzbekistan Airways and Air India concluded an interline agreement that opens new opportunities for convenient and seamless travel between the two countries—and beyond.

Under the terms of the agreement, Uzbekistan Airways passengers can now book through-tickets via Indira Gandhi International Airport in India for onward connections with Air India to over 30 domestic destinations, including Bengaluru, Chennai, Hyderabad, Ahmedabad, Amritsar, Goa, and Kochi. This partnership allows passengers to enjoy single-ticket booking, baggage check-through to their final destination, and boarding pass issuance for the entire journey at their initial departure airport.

Uzbekistan Airways operates flights to over 90 destinations worldwide, including the only transcontinental route between Central Asia and the U.S. among CIS airlines—Tashkent-New York-Tashkent. Currently, the airline offers regular flights from Tashkent to Delhi and Mumbai, as well as seasonal flights to Goa.
